
POLICE DEPARTMENT MONTHLY REPORT

In the month of October there were a total of **409** complaints generated by the Keith County Communications Center. **81** were Traffic Stops. Of the remaining complaints, **175** of them, or **53%**, required a written report by an officer. A graph or chart of October complaints is included on page 2.

The October Incident Based Reporting shows that the department had **39** reportable **Group A** offenses. The department was able to clear **23** of these offenses for a clearance rate of **59%** for October. We had 3 reports of **Criminal Mischief** for the month, with 2 being cleared for 67%. The department investigated 14 **Theft Offenses** and cleared 2 for a 14% clearance rate. A search warrant was served and stolen items were recovered from area Thefts, which will lead to more cases being cleared. The department investigated 5 **Assault Related Calls**, and cleared 3 for 60%. The department investigated 15 **Narcotics Call** and cleared 15 of them for a clearance rate of 100%. The department investigated 1 **Burglary Calls**, with 0 being cleared for 0%. The department investigated 2 **Felony Use of a Firearm Call**, with 1 being cleared for 100%.

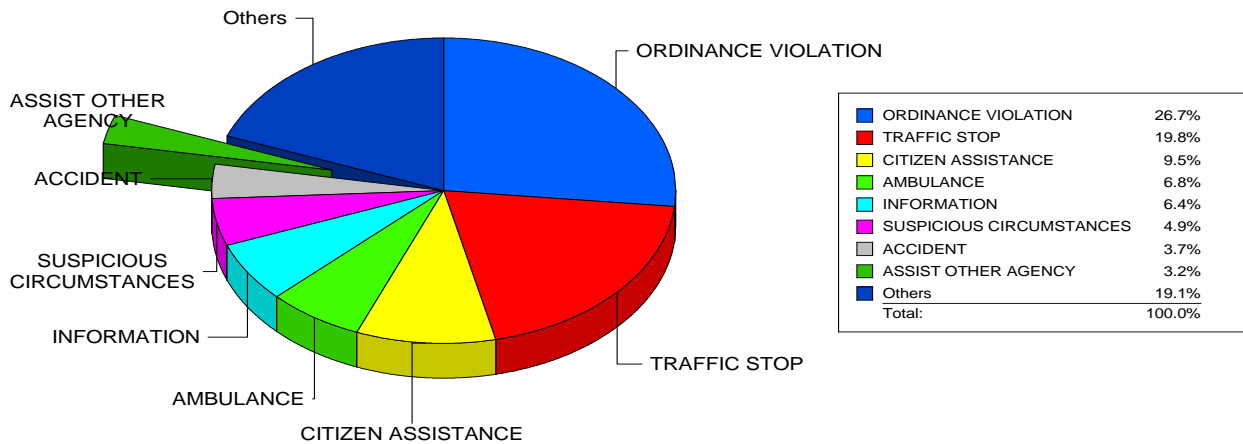
The department either arrested or issued criminal citations in lieu of arrest to **31** individuals in October for **50** criminal offenses. There were 27 adults and 4 juveniles. There were 21 males and 10 females arrested.

IMPOUND: In October, we towed 5 vehicles and released 2. We sold 20 vehicles at the October 14th Auction, clearing \$5,400. We also have 6 abandoned and surplus vehicles that will sell at the Schow Auction on November 18th.

Total profit to date for 2017 is \$2,765.00.
