Councilman Bassett introduced Ordinance 1308, entitled: An ordinance amending section 25-201, meetings of council general provisions, of the municipal code of the city of Ogallala, Nebraska and moved that the Statutory Rule requiring the reading on three different days be suspended and the ordinance may be read by title and moved for passage at this meeting. Councilman Block seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Kevin Block, Karl Elmshaeuser, Harold Peterson and Rodger Rankin. The following Council Members voted "No": None. Absent: None. Motion declared carried and the Statutory Rule was declared suspended for the consideration of this Ordinance.

Ordinance No. 1308 was read by title and, thereafter, Councilman Block moved for the final passage of the Ordinance. Councilman Bassett seconded the motion. The President then stated the question: "Shall Ordinance No. 1308 be passed and adopted?" Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Kevin Block, Karl Elmshaeuser, Harold Peterson and Rodger Rankin. The following Council Members voted "No": None. Absent: None. The passage and adoption of said Ordinance having been

concurred in by a majority of all members of the Council, the President declared the Ordinance adopted and the President, in the presence of the Council, signed and approved the Ordinance and the Clerk attested to the passage and approval of the same and affixed her signature thereto, a copy of said Ordinance No. 1308 being attached hereto and, by this express reference, incorporated herein and made a part hereof.

Charlie Votapka, Moul's Modern Builders, addressed the Council requesting a 90 day extension for the Downtown Improvement Project.

Councilman Rankin moved to approve a change order granting a 45 day extension to Moul's Modern Builders for the Downtown Improvement Project. Councilman Bassett seconded the motion. The following council members voted Yes: Darrell Bassett, Kevin Block, Harold Peterson and Rodger Rankin. Abstain: Karl Elmshaeuser. No: None. Motion declared carried.

Councilman Elmshaeuser introduced Ordinance 1309, entitled: An ordinance authorizing the issuance of a water revenue bond of the city of Ogallala, Nebraska, in the principal amount of up to two million seven hundred nineteen thousand one hundred nineteen dollars (\$2,719,119) for the purpose of paying the costs of constructing additions and improvements to the existing waterworks plant and distribution system of the city; authorizing the issuance of said bond in the form of a promissory note to evidence a loan from the Nebraska department of environmental quality; approving the execution and delivery of a loan contract with the Nebraska department of environmental quality; approving related documents with respect to said loan; prescribing the form, terms and details of said bond; pledging and hypothecating the revenues and earnings of the waterworks plant and distribution system owned by the city for the payment of said bond; entering into a contract on behalf of the city with the holder of said bond; authorizing the delivery of the bond to the Nebraska department of environmental quality; determining that interest on said bond shall not be excludable from gross income for purposes of federal income taxation; providing for the disposition of the bond proceeds and ordering the ordinance published in pamphlet form and moved that the Statutory Rule requiring the reading on three different days be suspended and the ordinance may be read by title and moved for passage at this meeting. Councilman Block seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Kevin Block, Karl Elmshaeuser, Harold Peterson and Rodger Rankin. The following Council Members voted "No": None. Absent: None. Motion declared carried and the Statutory Rule was declared suspended for the consideration of this Ordinance.

Ordinance No. 1309 was read by title and, thereafter, Councilman Block moved for the final passage of the Ordinance. Councilman Elmshaeuser seconded the motion. The President then stated the question: "Shall Ordinance No. 1309 be passed and adopted?" Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Kevin Block, Karl Elmshaeuser, Harold Peterson and Rodger Rankin. The following Council Members voted "No": None. Absent: None. The passage and adoption of said Ordinance having been concurred in by a majority of all members of the Council, the President declared the Ordinance adopted and the President, in the presence of the Council, signed and approved the Ordinance and the Clerk attested to the passage and approval of the same and affixed her signature thereto, a copy of said Ordinance No. 1309 being attached hereto and, by this express reference, incorporated herein and made a part hereof.

Councilman Elmshaeuser moved to authorize the Council President to sign the amendment to standard form of agreement between owner and engineer for professional services for adding Generator Set and Gas Lines to the Plans and Specifications for the South Water Source. Councilman Bassett seconded the motion. The following council members voted Yes: Darrell Bassett, Kevin Block, Karl Elmshaeuser, Harold Peterson and Rodger Rankin. No: None. Motion declared carried.

Aaron Smith, City Manager, updated the council on the Downtown Pavilion Project, including the proposed side curtains and signage.

Aaron Smith also addressed the council regarding forming a committee of two city council members and two school board members to discuss items of interest to both organizations. Councilmen Bassett and Elmshaeuser will participate in the joint city/school committee with Councilman Rankin serving as an alternate.

Aaron Smith informed the council of the upcoming League of Nebraska Municipalities Midwinter Conference to be held in Lincoln Nebraska February 23-25, 2014.

The City Council gave updates regarding their committee assignments as follows:

There being no further business to come before the council, Councilman Bassett moved to adjourn. Councilman Block seconded the motion.
