# REGULAR MEETING OF THE CITY COUNCIL

### AUGUST 26, 2014

A Regular Meeting of the City Council of the City of Ogallala, Nebraska, was held at City Hall Council Chambers in said City on the 26<sup>th</sup> day of August 2014, at 7:00 o'clock P.M. Notice of this meeting was simultaneously given to the President and to all members of the Council on August 23, 2014 and a copy of their Acknowledgement of Receipt of Notice and the Agenda is attached to these minutes. Availability of the agenda was communicated in the advance notice and in the Notice to the President and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. Proposed amendments would add requirements for regulations pertaining to proportional accessory buildings within residential zoning districts within the zoning jurisdiction of Ogallala at 7:02 P.M.

Ken Knoepfel, Planning and Zoning Administrator and Doug Davis addressed the council regarding the proposed amendment to Ogallala zoning code, chapter 44 pertaining to proportional accessory buildings.

Council Member Bassett opened a public hearing regarding an ordinance proposing amendments to Ogallala zoning code, Chapter 44. Proposed amendments would modify requirements for perimeter fencing within an Industrial zoning districts within the zoning jurisdiction of Ogallala at 7:07 P.M.

The fiscal year 2014-15 budget was discussed. The consensus of the council is to use cash reserves to fund several capital projects, rather than enter into lease/purchase agreements for the items.

Councilman Bassett announced ordinance 1319 was introduced and read for the first time on August 12, 2014. Councilman Bassett read ordinance 1319 by title: An ordinance amending Article 3 of Chapter 37, streets, the adoption of truck routes, the prohibition of truck parking on the streets of the City of Ogallala, to provide a penalty, of the municipal code of the City of Ogallala, Nebraska. Councilman Bassett announced ordinance 1319 has been read for the second time.

Burt Cyrus, Chris Hand, Andy Devries and Celeste Baker addressed the council regarding the proposed ordinance regarding the truck routes and truck parking on the streets of the City of Ogallala.

Council President Peterson entered the meeting at 7:44 P.M.

Council President Peterson announced that ordinance 1320 was introduced and read for the first time on August 12, 2014. Council President Peterson read ordinance 1320 by title: An ordinance amending Article 3 of Chapter 28, tobacco offences, the adoption of smoking prohibition in the parks, rendezvous square and recreational facilities of the City of Ogallala, Nebraska, and to provide penalty, of the municipal code of the City of Ogallala, Nebraska. Council President Peterson announced that ordinance 1320 has been read for the second time.

Council President Peterson closed a public hearing regarding an ordinance proposing amendments to Ogallala zoning code, Chapter 44. Proposed amendments would add requirements for regulations pertaining to proportional accessory buildings within residential zoning districts within the zoning jurisdiction of Ogallala at 7:59 P.M.

Councilman Bassett introduced ordinance 1321. Council President Peterson read Ordinance 1321 by title, an ordinance proposing amendments to Ogallala zoning code, Chapter 44. Proposed amendments would modify requirements for regulations pertaining to proportional accessory buildings within residential zoning districts within the zoning jurisdiction of Ogallala. Council President Peterson announced ordinance 1321 was read for the first time.

Council President Bassett closed a public hearing regarding an ordinance proposing amendments to Ogallala zoning code, Chapter 44. Proposed amendments would modify requirements for perimeter fencing within an Industrial zoning districts within the zoning jurisdiction of Ogallala at 8:12 P.M.

Councilman Bassett introduced Ordinance 1322, entitled: An ordinance proposing amendments to Ogallala zoning code, Chapter 44. Proposed amendments would modify requirements for perimeter fencing within an Industrial zoning districts within the zoning jurisdiction of Ogallala and moved that the Statutory Rule requiring the reading on three different days be suspended and the ordinance may be read by title and moved for passage at this meeting. Councilman Block seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Kevin Block, Harold Peterson and Rodger Rankin. The following Council Members voted "No": None. Absent: Karl Elmshaeuser. Motion declared carried and the Statutory Rule was declared suspended for the consideration of this Ordinance.

Ordinance No. 1322 was read by title and, thereafter, Councilman Bassett moved for the final passage of the Ordinance. Councilman Rankin seconded the motion. The President then stated the question: "Shall Ordinance No. 1322 be passed and adopted?" Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Kevin Block, Harold Peterson and Rodger Rankin. The following Council Members voted "No": None. Absent: Karl Elmshaeuser. The passage and adoption of said Ordinance having been concurred in by a majority of all members of the Council, the President declared the Ordinance adopted and the President, signed and approved the Ordinance and the Clerk attested to the passage and approval of the same and affixed her signature thereto, a copy of said Ordinance No. 1322 being attached hereto and, by this express reference, incorporated herein and made a part hereof.

Council President Peterson closed a public hearing regarding a project for which financial assistance is being sought from the Federal Transit Administration for a transit storage facility for housing public transit vehicles at 8:15 P.M.

Councilman Rankin moved not to pursue the public transportation project through the use of Federal Transit Authority Funds. Councilman Block seconded the motion. The following council members voted Yes: Kevin Block and Rodger Rankin. No: Darrell G. Bassett and Harold Peterson. Absent: Karl Elmshaeuser. Motion declared failed.

Councilman Bassett moved to submit the environmental and feasibility study to the federal government. Councilman Peterson seconded the motion. The following council members voted Yes: Darrell G. Bassett, Kevin Block and Harold Peterson. No: Rodger Rankin. Absent: Karl Elmshaeuser. Motion declared carried.

There being no further business to come before the council, Councilman Block moved to adjourn. Councilman Rankin seconded the motion. The following council members voted Yes: Darrell G.
