Council President Peterson opened a public hearing regarding a request to amend the Ogallala zoning code to allow a process for utility structures to be placed as a primary use by special exception in R-1 Residential Single Family zoning districts at 7:02 P.M.

Mayor Peterson proclaimed May 7, 2015 as National Day of Prayer in Ogallala Nebraska.

Terry Johnson, Community Redevelopment Authority, addressed the council to notify the city of the CRA's intent to enter into a redevelopment contract with O'Reilly Auto Enterprises, LLC.

Councilman Bassett introduced a resolution calling street, sanitary sewer and water improvement bond anticipation notes, series 2014, dated June 18, 2014. Councilman Block seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Darrell G. Bassett, Kevin Block, Harold Peterson and Rodger Rankin. The following council Members voted "No": None. Absent: Karl Elmshaeuser. Motion declared carried and Resolution No. 1442 adopted, a copy of said Resolution being attached hereto and by this express reference, incorporated herein and made a part hereof.

Councilman Bassett introduced a resolution calling refunding bonds, dated April 14, 2010, in the principal amount of \$620,000. Councilman Block seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Darrell G. Bassett, Kevin Block, Harold Peterson and Rodger Rankin. The following council Members voted "No": None. Absent: Karl Elmshaeuser. Motion declared carried and Resolution No. 1443 adopted, a copy of said Resolution being attached hereto and by this express reference, incorporated herein and made a part hereof.

Councilman Block introduced Ordinance 1335, entitled: An ordinance authorizing the issuance of general obligation various purpose bonds, series 2015, of the City of Ogallala, Nebraska, in the principal amount of one million five hundred thirty thousand dollars (\$1,530,000) to refund certain outstanding bonds of the city; for the purpose of paying the cost of paving streets and alleys within street improvement district no. 2014-1 and paying the cost of sewer and water improvements constructed in sanitary sewer extension district no. 2014-1 and water extension district no. 2014-1; prescribing the form of said bonds; providing for a sinking fund and for the levy and collection of taxes to pay said bonds; providing for the sale of the bonds; authorizing the delivery of the bonds to the purchaser; providing for the disposition of the bond proceeds and ordering the ordinance published in pamphlet form and moved that the Statutory Rule requiring the reading on three different days be suspended and the ordinance may be read by title and moved for passage at this meeting. Councilman Rankin seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Kevin Block, Harold Peterson and Rodger The following Council Members voted "No": None. Absent: Karl Elmshaeuser. Motion declared carried and the Statutory Rule was declared suspended for the consideration of this Ordinance.

Ordinance No. 1335 was read by title and, thereafter, Councilman Bassett moved for the final passage of the Ordinance. Councilman Block seconded the motion. The President then stated the question: "Shall Ordinance No. 1335 be passed and adopted?" Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Kevin Block, Harold Peterson and Rodger Rankin. The following Council Members voted "No": None. Absent: Karl Elmshaeuser. The passage and adoption of said Ordinance having been concurred in by a majority of all members of the Council, the President declared the Ordinance adopted and the President, signed and approved the Ordinance and the Clerk attested to the passage and approval of the same and affixed her signature thereto, a copy of said Ordinance No. 1335 being attached hereto and, by this express reference, incorporated herein and made a part hereof.

John Trecek, Ameritas Investment Corp. informed the council regarding creating a municipal facilities corporation. This non-profit corporation would serve at the pleasure of the Council President and Council, and exists for the purpose of acquiring equipment. Members of the municipal facilities corporation may not be a member of the council.

Councilman Block moved to approve KCAD's funding request of \$8,000 for the Multi-Sport Court project at Collister Park. Councilman Rankin seconded the motion.
