REGULAR MEETING OF THE CITY COUNCIL

NOVEMBER 24, 2015

A Regular Meeting of the City Council of the City of Ogallala, Nebraska, was held at City Hall Council Chambers in said City on the 24th day of November 2015, at 7:00 o'clock P.M. Notice of the meeting was given in advance thereof by publishing one time in the Keith County News and posting at the City Hall Administration Building as shown by the Certificate of Publication and Posting Notice attached to these Minutes. Councilman Block moved to excuse Councilman Elmshaeuser and Councilman Rankin from the November 24, 2015 City Council Meeting. Councilman Bassett seconded the motion. The following council members voted Yes: Darrell Bassett, Kevin Block and Harold Peterson. No: None. Absent: Karl Elmshaeuser and Rodger Rankin. Motion declared carried.

Wendell Upright addressed the Council regarding Light Pole Signs. He has been working with Ogallala Public Schools on the project, homebuilders association, the Chamber of Commerce regarding the light pole sign project. The consensus of the council is to proceed with the project.

Aaron Smith, City Manager addressed the Council regarding the proposed sales tax above 1.5% and the related Interlocal agreement.

Councilman Bassett introduced Ordinance 1340, entitled: An ordinance creating Street Improvement District No. 2015-1 in the City of Ogallala, Nebraska, ordering the construction of street improvements therein and ordering the publication of the ordinance

in pamphlet form and moved that the Statutory Rule requiring the reading on three different days be suspended. Councilman Block seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Kevin Block and Harold Peterson. The following Council Members voted "No": None. Absent: Karl Elmshaeuser and Rodger Rankin. Motion declared carried and the Statutory Rule was declared suspended for the consideration of this Ordinance.

Ordinance No. 1340 was read by title and, thereafter, Councilman Block moved for the final passage of the Ordinance. Councilman Bassett seconded the motion. The President then stated the question: "Shall Ordinance No. 1340 be passed and adopted?" Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Kevin Block and Harold Peterson. The following Council Members voted "No": None. Absent: Karl Elmshaeuser and Rodger Rankin. The passage and adoption of said Ordinance having been concurred in by a majority of all members of the Council, the President declared the Ordinance adopted and the President, in the presence of the Council, signed and approved the Ordinance and the Clerk attested to the passage and approval of the same and affixed her signature thereto, a copy of said Ordinance No. 1340 being attached hereto and, by this express reference, incorporated herein and made a part hereof.

Councilman Bassett introduced a resolution setting the date to hear objections to the creation of Street Improvement Districts No 2015-1 in the City of Ogallala. Councilman Block seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Darrell G. Bassett, Kevin Block and Harold Peterson. The following council Members voted "No": None. Absent: Karl Elmshaeuser and Rodger Rankin. Motion declared carried and Resolution No. 1461 adopted, a copy of said Resolution being attached hereto and by this express reference, incorporated herein and made a part hereof.
