Councilman Bassett moved to approve the special designated liquor license for Silverchair, LLC DBA 1 Eleven events to be held June 16, 2016 from 6:00 PM to 9:00 PM and on June 23, 2016 from 6:00 PM to 9:00 PM. Councilman Block seconded the motion. The following council members voted Yes: Darrell Bassett, Kevin Block, Harold Peterson and Rodger Rankin. No: None. Absent: Karl Elmshaeuser. Motion declared carried.

Councilman Bassett moved to approve the special designated license for Elks 1760 events to be held June 30, 2016 from 5:00 PM to 9:30 PM and July 7, 2016 from 5:00 PM to 09:30 PM.
