

SPECIAL MEETING OF THE CITY COUNCIL

JUNE 30, 2016

A Special Meeting of the City Council of the City of Ogallala, Nebraska, was held at City Hall Council Chambers in said City on the 30th day of June 2016 at 11:00 o'clock A.M. Present were: Vice-President of the Council: Karl Elmshaeuser; Council Members: Darrell Bassett, Kevin Block and Rodger Rankin. Absent: Harold Peterson. Interim City Manager: Jane Skinner. Deputy City Clerk: Roxane Welsh. City Attorney: Michael McQuillan.

Notice of the meeting was given in advance thereof by publishing one time in the Keith County News and posting at the City Hall Administration Building as shown by the Certificate of Publication and Posting Notice attached to these Minutes. Notice of this meeting was simultaneously given to the President and to all members of the Council on June 24, 2016, and a copy of their Acknowledgement of Receipt of Notice and the Agenda is attached to these minutes. Availability of the agenda was communicated in the advance notice and in the Notice to the President and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

The City Council discussed City Council compensation, and reviewed the compensation survey provided of comparable cities in Nebraska.

The Community Redevelopment Authority will be invited to the next budget workshop to discuss the Administrative Services Agreement with Keith County Area Development.

The preliminary highway allocation and municipal equalization fund revenue was discussed.

Councilman Elmshaeuser recommended that in the Fiscal Year 2016-2017 budget, the City Council keep the tax asking dollar amount constant, decreasing the levy.

Councilman Block exited the meeting at 12:42 P.M.

Councilman Peterson exited the meeting at 1:01 P.M.

The Council will meet for a budget priorities special meeting on Friday, July 8, 2016 at 8 A.M.

There being no further business to come before the council, Councilman Bassett moved to adjourn. Councilman Rankin seconded the motion.
