John Trecek, Ameritas Investment Corp., addressed the council regarding the issuance of General Obligation Various Purpose Bonds, Series 2017 in the principal amount of five hundred thousand dollars.

Council Member Nolde introduced Ordinance 1361, entitled: An ordinance authorizing the issuance of General Obligation Various Purpose Bonds, Series 2017, of the City Of Ogallala, Nebraska, in the principal amount of Five Hundred Thousand Dollars (\$500,000) issued for the purpose of paying the cost of constructing paving and related improvements in street improvement district nos. 2017-1 to 2017-3, inclusive, of the city; prescribing the form of said bonds; providing for a sinking fund and for the levy and collection of taxes to pay said bonds; providing for the sale of the bonds; authorizing the delivery of the bonds to the purchaser; providing for the disposition of the bond proceeds and ordering the ordinance published in pamphlet form and moved that the statutory rule requiring the reading on three different days be suspended. Council Member Schilz seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Dorie Nolde, Deb Schilz and Darryl Weddington. The following Council Members voted "No": None. Absent: Harold Peterson. Motion declared carried and the Statutory Rule was declared suspended for the consideration of this Ordinance.

Ordinance No. 1361 was read by title and, thereafter, Council Member Weddington moved for the final passage of the Ordinance. Council Member Nolde seconded the motion. The President then stated the question: "Shall Ordinance No. 1361 be passed and adopted?" Dave Kling, Police Chief and Nuisance Officer presented visual evidence regarding nuisance properties in the city of Ogallala.

ReNee Peterson addressed the council regarding the property at 3108 Spruce Acres.

Council Member Schilz removed resolution 1696 and introduced resolutions 1697 and 1698, resolutions of declared nuisance. Council Member Weddington seconded the motion.
