## SEPTEMBER 12, 2017

A Regular Meeting of the City Council of the City of Ogallala, Nebraska, was held at City Hall Council Chambers in said City on the 12th day of September, 2017, at 7:00 o'clock P.M. Notice of the meeting was given in advance thereof by publishing one time in the Keith County News and posting at the City Hall Administration Building as shown by the Certificate of Publication and Posting Notice attached to these Minutes. Notice of this meeting was simultaneously given to the President and to all members of the Council on September 8, 2017 and a copy of their Acknowledgement of Receipt of Notice and the Agenda is attached to these minutes. Availability of the agenda was communicated in the advance notice and in the Notice to the President and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. The President of the Council stated this meeting is being convened in accordance with the Open Meetings Act and acknowledged a copy of the Open Meetings Act being duly posted in the southeast Corner of Council Chambers.

Absent: None. Motion declared carried and Resolution 1720 was adopted, a copy of said Resolution being attached hereto and by this express reference, incorporated herein and made a part hereof.

Council Member Nolde introduced Ordinance 1363, entitled: An ordinance to appropriate the sums of money deemed necessary to defray, by means of taxation, all the necessary expenses and liabilities of the City of Ogallala, Nebraska , for the fiscal year ending September 30, 2018; specifying the objects or purposes for which such appropriations are made and the amount appropriated for each object, or purpose; containing the percentage levied for each object or purpose; providing for the certification of this ordinance to the County Clerk of Keith County, Nebraska; and prescribing the time when this ordinance shall be in full force and take effect and moved that the statutory rule requiring the reading on three different days be suspended. Council Member Weddington seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Dorie Nolde, Harold Peterson, Deb Schilz and Darryl Weddington. The following Council Members voted "No": None. Absent: None. Motion declared carried and the Statutory Rule was declared suspended for the consideration of this Ordinance.

Council President Bassett closed a public hearing regarding a request to rezone property located at 349 Highway 30 West, more particularly described as a 10.09-Acre Tract in the SE <sup>1</sup>/<sub>4</sub> of Section 10, Township 13 North, Range 39 West of the 6<sup>th</sup> P.M. Proposed rezoning is from C-2 *Highway Business District to* I-1 *Industrial District* (*The RV Storage Place L.L.C.*) at 7:28 P.M.

Council Member Nolde introduced Ordinance 1364, entitled: An Ordinance Rezoning The Following Described Real Estate: A tract of land located in the SE¼ of Section 10, Township 13 North, Range 39 West of the 6th P.M., Keith County, Nebraska, being more particularly described as follows: Commencing at the Center Quarter corner of Section 10, Township 13 North, Range 39 West of the 6th P.M., Keith County, Nebraska; thence S 00°10'00" W on the west line of the SE<sup>1</sup>/<sub>4</sub> of said Section, 212.24 feet; thence S 88°22'38" E 1401.93 feet to a point on the north line of Highway #30 Right-of-Way, also being the beginning of a nontangent 5523.29 foot radius curve concave northwesterly; thence southwesterly on the arc of said curve 1114.64 feet (chord bearing S 68°08'01" W, chord length 1112.76 feet) on said line; thence S 16°05'06" E on said Right-of-Way line, 15.00 feet, to the beginning of a nontangent 5538.29 foot radius curve concave northwesterly; thence southwesterly on the arc of said curve 355.43 feet (chord bearing S 75°45'13" W, chord length 355.38 feet) on said Right-of Way line; thence S 77°35'32" W on said Right-of-Way line, 30.72 feet to a point on said west line of the SE<sup>1</sup>/<sub>4</sub>; thence N 00°10'00" E on said line 562.61 feet to the Point of Beginning containing 10.09 acres, more or less from C-2 Highway Business District to I-1 Industrial District and moved that the statutory rule requiring the reading on three different days be suspended. Council Member Nolde moved to approve a subdivision plat titled Pony Express Subdivision of a Tract of Land located in the SE <sup>1</sup>/<sub>4</sub> of Section 7 and Outlot "A" of Great Western Properties Subdivision # 1, All located in Township 13 North, Range 38 west of the 6th P.M., Keith County, Nebraska. Council Member Schilz seconded the motion. The following council members voted Yes: Darrell Bassett, Dorie Nolde, Harold Peterson, Deb Schilz and Darryl Weddington. No: None. Absent: None. Motion declared carried.

City Manager Bruce Smith updated the Council regarding the Airport Hangar Rehabilitation Project. The city has completed the contract portion of the contract with Allied Insurance and contractor Abet Lerew.
