Council Member Peterson introduced resolution 1751, a resolution to submit the issue of continuing to impose the one-half (1/2) cent local option sales and use tax previously approved by the electors of the City of Ogallala at a special election on November 5, 1996, upon transactions within the corporate limits of Ogallala, Nebraska, to the registered voters of Ogallala at the Primary Election to be held on May 15, 2018. Council President Bassett read the resolution by title and Council Member Weddington seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Darrell G. Council President Bassett closed a public hearing regarding a Community Development Block Grant Tourism Application for The Driftwood at 7:39 P.M.

Council Member Schilz introduced resolution 1752, a resolution authorizing the Chief Elected Official to sign an application for CDBG funds for the City of Ogallala, Nebraska. Council President Bassett read the resolution by title and Council Member Weddington seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Darrell G. Motion declared carried and Resolution 1752 was adopted, a copy of said Resolution being attached hereto and by this express reference, incorporated herein and made a part hereof.

Council Member Weddington moved to approve the proposal from DJA Construction for the construction of a new police department garage in the amount of \$22,682. Motion declared carried.

Council Member Peterson introduced Ordinance 1367, entitled: An Ordinance authorizing the issuance of a promissory note in an amount not to exceed \$2,176,684.00 to evidence a loan from the Nebraska Department of Environmental quality for the purpose of paying the costs of constructing additions and improvements to the existing waterworks plant and distribution system of the City; approving the execution and delivery of a loan contract with the Nebraska Department of Environmental Quality; approving related documents with respect to said loan and promissory note; and ordering the ordinance published in pamphlet form and moved that the statutory rule requiring the reading on three different days be suspended. Council Member Weddington seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Dorie Nolde, Harold Peterson, Deb Schilz and Darryl Weddington. The following Council Members voted "No": None. Absent: None. Motion declared carried and the Statutory Rule was declared suspended for the consideration of this Ordinance.

Ordinance No. 1367 was read by title and, thereafter, Council Member Schilz moved for the final passage of the Ordinance. Council Member Peterson seconded the motion. The President then stated the question: "Shall Ordinance No. 1367 be passed and adopted?"
