Council President Bassett read Ordinance 1368 by title, An Ordinance Authorizing and Directing Participation by the City of Ogallala, Nebraska in The Interlocal Agreement (Creating the Public Alliance for Community Energy); Authorizing and Directing the Execution of Said Agreement; to prescribe the time when this Ordinance 1368 has been read for the second time.

Council Member Nolde moved that the statutory rule requiring the reading on three different days be suspended. Council Member Peterson seconded the motion.
