Council President Bassett stated Ordinance 1371 was read for the first time on May 8, 2018, the second time on May 22, 2018, and the third and final time on June 12, 2018. Council Member Weddington moved to reject Ordinance 1371, an ordinance to rezone property located at 2385 North Spruce Street, more particularly described as a 3.3-Acre portion of land located in the South 393.13 feet of the West 374.75 feet of a Tract in the NE ¼ of Section 31, Township 14 North, Range 38 West of the 6th P.M., in Keith County, Nebraska: Proposed rezoning is from A-2 Agricultural Residential District to C-2 Highway Business District. Council Member Weddington seconded the motion. The President then stated the question: "Shall Ordinance No. 1371 be rejected?" Upon roll call vote, the following Council Members voted "Yes": Darrell Bassett, Harold Peterson and Darryl Weddington. The following Council Members voted "No": Dorie Nolde. Absent: Deb Schilz. The President declared the Ordinance failed.

CJ Poltack, Executive Director – WCNDD, addressed the council regarding the Driftwood LLC CDBG 17-TD-001 project.

Council Member Peterson moved to approve CDBG 17-TD-001 (Driftwood LLC) Special Conditions for Release of Funds: Grantee Information Sheet; Environmental Review; Authorization of Request Funds, Implementation Schedule; Financial Management; Procurement Standards; Fair Housing; Excessive Force Certification; Limited English Proficiency; Division of Duties and authorize the Council President to sign the documents. Council Member Nolde seconded the motion. The following council members voted Yes: Darrell Bassett, Dorie Nolde, Harold Peterson, and Darryl Weddington. No: None. Absent: Deb Schilz. Motion declared carried.

CJ Poltack addressed the council regarding making application for a CDBG Owner Occupied Housing Rehabilitation grant.

Council Member Weddington moved to authorize West Central Nebraska Development District to proceed with the pre-application for CDBG Owner Occupied Housing Rehabilitation funds and commit to \$15,750 of matching funds. Council Member Nolde seconded the motion. The following council members voted Yes: Darrell Bassett, Dorie Nolde, Harold Peterson, and Darryl Weddington. No: None. Absent: Deb Schilz. Motion declared carried.

Brian Vasa, Chairman of the Community Redevelopment Authority addressed the council regard the CRA's intent to enter into a contract with Driftwood, LLC – 114 North Spruce Street.

Council Member Nolde moved to approve the agreement for extension of time to deliver notice of intent not to renew with Keith County Area Development and Keith County. Council Member Weddington seconded the motion. The following council members voted Yes: Darrell Bassett, Dorie Nolde, Harold Peterson, and Darryl Weddington. No: None. Absent: Deb Schilz. Motion declared carried.
