A Regular Meeting of the City Council of the City of Ogallala, Nebraska, was held at City Hall Council Chambers in said City on the 27th day of November, 2018, at 7:00 o'clock P.M. Present were: President of the Council: Darrell G. Bassett; Council Members: Dorie Nolde, Deb Schilz and Darryl Weddington. Absent: Harold Peterson. City Manager: Bruce Smith. City Clerk: Jane Skinner. City Attorney: Joshua Wendell.

Notice of the meeting was given in advance thereof by publishing one time in the Keith County News and posting at the City Hall Administration Building as shown by the Certificate of Publication and Posting Notice attached to these Minutes. Notice of this meeting was simultaneously given to the President and to all members of the Council on November 21, 2018 and a copy of their Acknowledgement of Receipt of Notice and the Agenda is attached to these minutes. Availability of the agenda was communicated in the notice and in the Notice to the President and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. The President of the Council stated this meeting is being convened in accordance with the Open Meetings Act and acknowledged a copy of the Open Meetings Act being duly posted in the southeast Corner of Council Chambers.

C. Council Representative / Liaison Appointments:

These positions are Council Representative/Liaison appointments generally held by a Council member or representative of the Council for an indefinite term. The only statutory board requiring appointments are the Board of Health (held by the Council President).

1) Board of Health (Council President)

This is a statutory, full voting position. State statute requires that the Council President serve as Chairman of the Board of Health. Therefore, Buck Bassett has been serving on this board. The Board meets monthly on the 3rd Tuesday at 7:00 PM at City Hall. The Board's primary function is to deal with public health and nuisances.

2) Chamber of Commerce

This is an ex-officio, non-voting position. Dorie Nolde has been serving in this position. The Board meets monthly on the 3rd Thursday at 7:00 AM at the KCAD Conference Room. The Board's primary function is the promotion of Ogallala and Keith County.

3) Keep Keith County Beautiful

This is an ex-officio, full voting position. Pete Peterson has been serving in this position. The Board meets monthly on the 2nd Wednesday at 12:00 PM at City Hall. The Board's primary function is to promote recycling and a litter-free community.

4) Keith County Area Development

This is an ex-officio, non-voting position. Deb Schilz has been serving in this position. The Board meets the 3rd Tuesday at 12:00 PM at KCAD office. The Board's primary function is to promote economic development activities in Ogallala/Keith County.

5) Kenfield Petrified Wood Gallery

This is an ex-officio full voting position. Buck Bassett has been serving in this position. The board meets monthly on the last Monday at 5:00 PM at the Gallery.

The Board's primary function is the management of the gallery. (Meeting date/time subject to change)

6) Library Board

This is an ex-officio, non-voting position. Darryl Weddington has been serving in this position. The Board meets monthly on the third Wednesday at Noon at the Library. The Board's primary function is management of the Library.

7) Ogallala Community Hospital Advisory Board.

This is an ex-officio, non-voting position. Darryl Weddington has been serving in this position. The Board meets quarterly on the 4th Monday at 5:30 PM at the Hospital (February/May/August/November). The Board's primary function is advisory to the hospital authority.

8) West Central Development District (1 + Alternate).

This is an ex-officio, full voting position. Dorie Nolde has served as primary representative and Deb Schilz has served as the alternate. The Board's primary function is the delivery and administration of economic development programs in an 18 county area. The secondary function is the management of operations and personnel.

C. Planning and Zoning – Walmart Permanent Parking Lot Improvements and Ingress and Egress Improvements to City Right of Way Adjacent to Parking Lot

At the July 14th, 2016 City Council meeting, the Council passed a motion, at Walmart's

request, to construct temporary improvements to Lot 3 of Plunkett Original Addition, to allow for truck parking with Walmart agreeing to construct permanent improvements within two years of the Certificate of Occupancy which was given to Walmart on August 17, 2016. At this time, Walmart has not completed the permanent improvements. This was discussed at the November 27th Council meeting. It would be my recommendation that we put a new date on Walmart, for at least plans and specifications for the permanent improvements or the road to the parking lot will be closed. I am recommending a date of February 28, 2019.

Recommended motion:

"Move to allow Walmart until February 28, 2019 to provide to the City plans and specifications and a construction schedule for permanent ingress and egress improvements to Lot 3, Plunkett Original Addition Replat #1, or the road and truck parking lot will be closed."

D. Planning and Zoning – Section 7-202 – Building Moving permits; fees, of the Municipal code of the City of Ogallala (Ord. 1378).

In the municipal code, it requires a building that is moved into or within the municipality, to have approval from neighboring property owners residing within 300 feet of the building's final resting place. This can become problematic, especially if the applicant and property owners do not get along.

The proposed code eliminates the need for neighbor consent and places approval or disapproval directly onto the City Council. The proposed code does require a public hearing for interested parties to voice any concerns also the code requires notice be sent to neighboring property owners.

If you would like to waive the requirements to read the ordinance 3 times, here is the recommended motion:

Recommended motion (by ordinance):

"I would introduce Ordinance 1378 and move to suspend the rules, so that the ordinance may be read by title and moved for passage at this meeting."

After the motion receives a second, the vote is called for.

E. Planning and Zoning – Request to vacate portions of City street and alley right-of-way located in the following areas: South of Lots 1-4, Block 40, Original Town of Ogallala; Block 65, Aufdengarten's Second Addition; Block 48, Aufdengarten's Second Addition. (Ord. 1379).

Nebraska Public Power District is in the process of re platting their property south of the railroad at their former place of business on West Riverdale Drive. NPPD's surveyor found that portions of their land thought to be vacated, is in fact not and has no record of ever being vacated. These portions of right-of-way have been used by Nebraska Public Power with the exception of West B Street which is actually a channel easement for storm drainage which there is already a recorded easement in effect. This street and alley right-of-way are not needed by the City and I would recommend vacating them.

If you would like to waive the requirements to read the ordinance 3 times, here is the recommended motion:

- all that portion of the east half of "B" Street lying south of the north line of Lot 4, if extended westerly, Block 48, Aufdengarten's Second Addition to the City of Ogallala, Keith County, Nebraska to the South Platte River, reserving herewith the channel easement granted and conveyed to the City of Ogallala as recorded in miscellaneous book 62, page 395 in the Office of the Register of Deeds for Keith County, Nebraska. For the City of Ogallala, Nebraska to provide for publication of this ordinance; and providing for an effective date."

A Council member may then: "Move to adopt Ordinance 1379."

F. Wastewater – Proposed Consent Order in NDEQ Case No. 3471.

Because of the issues we are having with the digester lid at the Waste Water Treatment Plant, we have been having problems meeting our discharge limits as set by our National Pollution Discharge Elimination System permit. We are working on a solution and have budget money to make the necessary repairs to the system. The Nebraska Department of Environmental Control has issued a Proposed Consent Order to us that would set activities and schedules for the City to meet in order to come back under compliance with our permit. There is nothing in the order that we are not expecting to follow so after talking with City Attorney McQuillan and Tom Werblow, our engineer on the project, we recommend agreeing to the consent order.
