Council Member Nolde introduced Ordinance 1383, entitled: An Ordinance granting to the Nebraska Public Power District, a public corporation and political subdivision of the State of Nebraska, its successors and assigns, the non-exclusive right and franchise for a period of Twenty-Five (25) Years to erect, operate and maintain an electric light and power system in the City of Ogallala for the purpose of furnishing electric energy to said City of Ogallala and the inhabitants thereof; limiting the maximum charges for such energy; providing certain regulations with reference thereto; and all things incidental to the purposes thereof; repealing all ordinances and parts of ordinances in conflict therewith; directing the publication of this Ordinance and prescribing the time when this Ordinance shall be in full force and effect and moved that the statutory rule requiring the reading on three different days be suspended. Council Member Block seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Kevin Block, Dorie Nolde, Deb Schilz and Darryl Weddington. The following Council Members voted "No": None. Absent: LD Walker. Motion declared carried and the Statutory Rule was declared suspended for the consideration of this Ordinance.

Ordinance No. 1383 was read by title and, thereafter, Council Member Nolde moved for the final passage of the Ordinance. Council Member Block seconded the motion. The President then stated the question: "Shall Ordinance No. 1383 be passed and adopted?" Council Member Nolde introduced Ordinance 1385, entitled: An Ordinance authorizing the issuance of Highway Allocation Fund pledge bonds, series 2019, of the City of Ogallala, Nebraska, in the principal amount of not to exceed six hundred thirty-five thousand dollars (\$635,000) for the purpose of paying the costs of constructing certain street and related improvements of the City; prescribing the form of said bonds; pledging funds to be received by the City from the State of Nebraska Highway Allocation fund for the payment of said bonds; providing for the levy and collection of taxes to pay the same if necessary; authorizing the officers of the City to establish the final terms of the bonds within certain parameters; appointing a paying agent and registrar; authorizing the delivery of the bonds to the purchaser; providing for the disposition of the bond proceeds; approving post-issuance tax compliance policies; authorizing a bond purchase agreement and other related documents; and ordering the ordinance published in pamphlet form and moved that the statutory rule requiring the reading on three different days be suspended.
