Original Town of Ogallala, Keith County, Nebraska., and moved that the statutory rule requiring the reading on three different days be suspended. Council Member Weddington seconded the motion. The passage and adoption of said Ordinance having been concurred in by a majority of all members of the Council, the President declared the Ordinance adopted and the President, in the presence of the Council, signed and approved the Ordinance and the Clerk attested to the passage and approval of the same and affixed her signature thereto, a copy of said Ordinance No. 1390 being attached hereto and, by this express reference, incorporated herein and made a part hereof.

Council President Nolde moved to approve Wastewater Improvements 2018-1 – Change Order #3 with DeWine Mechanical in the amount of \$5,422.00. Council Member Weddington seconded the motion. Council Member Block introduced Ordinance 1391, entitled: An Ordinance authorizing the issuance of a Sewer Revenue Bond of the City of Ogallala, Nebraska, in the principal amount of up to two million eighty thousand dollars (\$2,080,000) for the purpose of paying the costs of constructing additions and improvements to the existing sanitary sewer plant and sewer system of the City; authorizing the issuance of said bond in the form of a promissory note to evidence a loan from the Nebraska Department of Environment and Energy; approving the execution and delivery of a loan contract with the Nebraska Department of Environment and Energy; approving related documents with respect to said loan; prescribing the form, terms and details of said bond; pledging and hypothecating the revenues and earnings of the sanitary sewer plant and sewer system owned by the city for the payment of said bond; entering into a contract on behalf of the City with the holder of said bond; authorizing the delivery of the bond to the Nebraska Department of Environment and Energy; determining that interest on said bond shall not be excludable from gross income for purposes of federal income taxation; providing for the disposition of the bond proceeds and ordering the ordinance published in pamphlet form, and moved that the statutory rule requiring the reading on three different days be suspended. Council Member Weddington seconded the motion. Upon roll call vote, the following Council Members voted "Yes": Kevin Block, Dorie Nolde, Deb Schilz, LD Walker and Darryl Weddington. The following Council Members voted "No": None. Absent: None. Motion declared carried and the Statutory Rule was declared suspended for the consideration of this Ordinance.

Ordinance No. 1391 was read by title and, thereafter, Council Member Block moved for the final passage of the Ordinance. Council Member Nolde seconded the motion. The President then stated the question: "Shall Ordinance No. 1391 be passed and adopted?" Council Member Nolde moved to approve the purchase of real estate from Matthew J. and Sandy R. Waitley a tract of land located in the NW 1/4 of Section 31, T. 14 N., R. 38 W. of the 6th P.M., Keith County, Nebraska, being more particularly described as follows: Commencing at the NW corner of Section 31, T.14 N., R.38 W. of the 6th P.M., Keith County, Nebraska; thence S 89°56'17" E on the north line of the NW 1/4 of said Section, 1591.33 feet to the NE corner of an 11.48 acre tract, known as "Tract 6", surveyed by Ryan E. Dickinson, RLS 554, dated October 10, 2011; thence now following the east line of said "Tract 6", S 00°01'06" W 186.98 feet; S 38°03'40" E 549.38 feet; thence S 00°00'31" W 261.99 feet to the Point of Beginning; thence S 00°00'12" E 121.09 feet to the NE corner of a tract of land surveyed by Robert D. Temple, LS 303, dated October 1976; thence now leaving the east line of said "Tract 6" and now following said Temple tract, N 89°59'25" W 83.06 feet; thence N 00°09'43" W 88.07 feet; thence N 89°59'58" W 100.22 feet; thence S 00°05'17" E 198.89 feet to a point on the south line of said "Tract 6"; thence N 89°54'06" W on the south line said "Tract 6", 70.00 feet; thence N 00°05'17" W 231.77 feet; thence S 89°59'57" E 253.04 feet to the Point of Beginning containing 0.68 acres, more or less.
