

A REGULAR MEETING OF THE CITY COUNCIL

MARCH 9, 2021

A Regular Meeting of the City Council of the City of Ogallala, Nebraska, was held at City Hall Council Chambers in said City on the 9<sup>th</sup> day of March, 2021, at 7:00 o'clock P.M. Present were: President of the Council: Deb Schilz; Council Members: Darrell G. Bassett, Kevin Block, and Darryl Weddington. Absent: Chris Laflan. City Manager: Bruce Smith. City Clerk: Jane Skinner. City Attorney: Michael McQuillan.

Notice of the meeting was given in advance thereof by publishing one time in the Keith County News and posting at the City Hall Administration Building as shown by the Certificate of Publication and Posting Notice attached to these Minutes. Notice of this meeting was simultaneously given to the President and to all members of the Council on March 5, 2021 and a copy of their Acknowledgement of Receipt of Notice and the Agenda is attached to these minutes. Availability of the agenda was communicated in the notice and in the Notice to the President and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. The President of the Council stated this meeting is being convened in accordance with the Open Meetings Act and acknowledged a copy of the Open Meetings Act being duly posted in the southeast Corner of Council Chambers.

Jane Skinner, City Clerk-Treasurer presented the financial report for February 2021.

Council Member Bassett moved to recommend that the Addition to License for Class C Liquor License Cornhusker Lanes LLC DBA Cornhusker Lanes be approved by the Nebraska Liquor Control Commission. Council Member Block introduced Resolution 2034, a resolution adopting and approving the execution of an Agency Agreement with Nebraska Department of Transportation, Aeronautics Division For Grant No. 3-31-0061-014-2021 to be submitted by The Department to The Federal Aviation Administration to obtain federal non-development economic assistance for the airport under the provisions of The Federal CRRSA Act.
