

A REGULAR MEETING OF THE CITY COUNCIL

APRIL 13, 2021

A Regular Meeting of the City Council of the City of Ogallala, Nebraska, was held at City Hall Council Chambers in said City on the 13th day of April, 2021, at 7:00 o'clock P.M. Notice of the meeting was given in advance thereof by publishing one time in the Keith County News and posting at the City Hall Administration Building as shown by the Certificate of Publication and Posting Notice attached to these Minutes. Notice of this meeting was simultaneously given to the President and to all members of the Council on April 9, 2021 and a copy of their Acknowledgement of Receipt of Notice and the Agenda is attached to these minutes. Availability of the agenda was communicated in the notice and in the Notice to the President and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. The President of the Council stated this meeting is being convened in accordance with the Open Meetings Act and acknowledged a copy of the Open Meetings Act being duly posted in the southeast Corner of Council Chambers.

Mayor Schilz proclaimed April 11-17, 2021 as Public Transit Week.

Jane Skinner, City Clerk-Treasurer presented the financial report for March 2021.

Council Member Weddington moved to approve the lowest responsible bid from Weathercraft Companies for the Indoor Pool Roof in the amount of \$72,575. Council Member Laflan seconded the motion.
