B. Community Development – State of Nebraska Department of Economic Development Community Development Block Grant Contract Number 18-HO-33058 – Owner Occupied Property Rehabilitation.

Last September, the city applied to the Nebraska Department of Economic Development for a Community Development Block Grant for an Owner Occupied Housing Rehabilitation Project. The total amount of CDBG funds to be paid to the city will not exceed \$119,004. Five homes are expected to be rehabilitated during the contract, which must be completed by December 10, 2020. The City has also pledged \$15,750 of Keno funds as match toward the project.

### **Recommended motion:**

"Move to approve the State of Nebraska Department of Economic Development

Community Development Block grant Contract No. 18-HO-33058 Owner-Occupied

Property Rehabilitation and authorize the Council President to sign the contract."

C. Library – Library Building Contract

We opened bids on February 7<sup>th</sup> for the new Library Building. Seven bids were received and we feel we received very good competitive bids for the project. The low bid was received from Rogge General Contractors, Inc from Lincoln. Their base bid was for \$2,081,000 and the alternate bid for the addition of concrete sidewalks and north parking area was \$58,000 making the total \$2,139,000. We are recommending, and our engineers, JEO Consulting concur, to recommend accepting the bid from Rogge General Contractors.

#### **Recommended motion:**

"Move to accept the lowest responsible bid from Rogge General Contractors, Inc in the amount of \$2,081,000 including the alternate #1 in the amount of \$58,000 and authorize the Council President to sign the contract."

Currently, the minimum age is 16. This resolution also amends the job title salary range table to authorize 6 employees in the Library Clerk Assistant position, currently there are 5 authorized positions.

E. O.V.F.D. – Volunteer Emergency Responders Incentive Act Certified List of Volunteers – LB886.

LB886 provides for a \$250 tax credit for Volunteer Emergency Responders who obtain a minimum of 50 points for various activities within the department for two years. Included in your packet is the list of volunteers who qualified in 2018. A volunteer who qualifies for two consecutive years on the list is then eligible for the tax credit.
